Finally, the extended abstract should include in-text references, and the references should match with the bibliography.
- For articles whose main text is in English, the extended Turkish abstract should contain at least 40% of
 the English text in terms of word count. In the extended Turkish abstract, mainly information related to
 the Methods and Results sections should be presented. Figures and/or tables in the main text should not
